The shareholders voted in favour of the proposal by the Board of Directors to appropriate the profit (distribution of CHF 2.425 (gross) as an ordinary dividend from the profit for the year, CHF 1.57625 net after deducting 35% withholding tax) and the distribution of CHF 2.425 from the statutory reserves from capital contributions (free from withholding tax). The serving Board of Directors of Burkhalter Holding Ltd, the Chairman of the Board Gaudenz F. Domenig and the auditors KPMG AG were re-elected for another term of office of one year, as were the members of the Compensation Committee and the independent proxy.
